The attention of all the District Educational Officers and Ex-Officio District Project Coordinators, RMSA in the State are informed that in the references 3rd read above an amount of Rs. 69,00,000/- (Rupees Sixty Nine lakhs only) @ Rs. 3,00,000/- (Rupees Three lakhs only) was released towards payment of salaries to the staff viz. Superintendent and Sr. Assistant working in the District RMSA Office from the month of May, 2011 to July, 2011 and they were requested to meet the budget from the available MMER funds of this office. The amount so released has covered the salaries of two staff members for the month of August, 2011 also.

The salaries of Accounts Officers who have joined on deputation basis from the Director of Treasuries & Accounts are also have to be claimed from the date of their joining in the RMSA District offices.

Hence sanction is hereby accorded for an amount of Rs. 69,00,000/- (Rupees Sixty Nine lakhs only) @ Rs. 3,00,000/- (Rupees Three lakhs only) to each of the 23 Districts towards payment of salaries to the Accounts Officers, Superintendent and Sr. Assistant working in District Offices in RMSA for the month from September, 2011 to November, 2011 as 2nd quarter from the available MMER funds of this office.

Therefore the Finance & Accounts Officer of this office is requested to take necessary action in releasing the above budget from the available MMER funds to the Districts as per the rules in vogue with instructions to the District Educational Officer and Ex-Officio District Project Coordinators to pay salaries to the staff working under RMSA and in respect of staff who are on strike their salaries may be drawn as per the instructions or orders issued by Government from time to time.
